INITIAL ALLOCATION STATEMENT FOR SWAINSWICK CHURCH SCHOOL

PLACES AVAILABLE: 12

As Swainswick Church School was oversubscribed it was necessary to use the admissions criteria, as published in 'A Primary School for Your Child – 2021/22', to allocate the places available at the school. Applications for all schools are considered under an equal preference system which means that all preferences (1st, 2nd & 3rd) for each school are considered equally. If there are any cases where more than one of the school preferences named on the application form could have been met only the highest preference school has been allocated.

A total of **33 preferences** were originally received for Swainswick Church School which has an Admission Number of **12.**

If, under any of the categories listed, places were offered and refused, priority was given to those who live closest to the school as measured in a direct line between the home address and the school.

How the initial allocation of places was made for this school:

- **1 Category 1 Applicants** Looked after children or previously looked after children.
- **7 Category 2 Applicants** Children with a sibling attending Swainswick Church School at the time the admission application is submitted.
- **0 Category 3 Applicants** Children of paid school staff, employed at the school at the time of the child's admission date.
- 4 Category 4 Applicants Children not satisfying a higher criterion and living closest to Swainswick Church School by straight line measurement. The furthest direct line distance between the preferred school and the home address offered in this category was 1.095 miles.
- **2** Children in total have initially been refused a place at Swainswick Church School. (All other preferences originally considered have qualified for another school as a higher preference)
